ORDER

WHEREAS, if exercise of the powers conferred by sub-section (2) of Section 33 of the National Council for Landson Act. 1993 (3). Fraction I ducation Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and December 2003) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the

AND WHEREAS, the ecognition was granted by NRC to Pratap Baladur Post Graduate College, Pratapgath City, Pratapgarh, Pin Code - 230002, State - Uttar Pradesh for B.P.Ed, Course vide order No. F. NRC/NC 1 F/F-7/UP-2310/2008/40074-40080 dated 29.02.2008 with an annual intake of 50 scats.

AND WIILBEAS, the institution Pratap Bahadur Post Graduate College, Pratapgarh City, Pratapgarh Pin Code - 2.00002, State - Uttar Fradesh has by affidavit consented to come under New Regulations and sought for one basic unit in B.P.F.d., which require additional facilities.

- AND WIII REAS, it has been decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions nantely
- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required documents by May 30th, 2016.
- The application-Institution for additional unit will be required to submit the required documents such as land (iii) documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforms available on the website to the Regional Committee in proof of having provided additional facilities before May 30th 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- The institution shall identified/selected the faculty/staff and obtained the approval from the affiliating body for the same latest by 20th February, 2016 and same be conveyed to the Northern Regional Committee by that date
- The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition after May 30th, 2016, If it is found by the Regional € emmittee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- In-case, any existing institution's matter is sub-judice under court direction/SCTI under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCEWcomplaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt, and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Pegional Committee in respect of Section 17/complaint cases etc.

Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Pecognition Order to Pratap Bahadur Post Graduate College, Pratapgarh City, Pratapgarh, Pin Code - 230002, State - Ultra Pradesh for conducting B.P.Ed. programme of two years duration with an annual intake of 50 for one basic unit of 40 students from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein-before

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other (University (tate Govt.) shall also be required to verify the authenticity of the land & building documents as well as appoint of requisite teaching & non-teaching staff as ner provisions of the NCTR parameter. regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable.
